# **Terms and Conditions**

# **ACCEPTANCE OF THE TERMS OF USE**

These Terms of Use (Terms and Conditions) are entered into by and between you and 4FORALL FOOTBALL ACAD-EMY (4FORALL) ("Our", "we" or "us"). The following terms and conditions, together with any documents. We expressly incorporate by reference, govern your access to and use of our website, including any content, functionality and services offered on the "Website" either online or offline.

Please read the Terms and Conditions carefully before you start to use or access our services. By agreeing to the Terms of Use when this option is made available to you, you accept and agree to be bound and abide by these Terms and Conditions, and our Privacy Policy.

#### **ELIGIBILITY**

4FORALL FOOTBALL ACADEMY is open to boys and girls between the ages of 9 and 13. The participant must be at least 9 years of age or no older than 13 years of age.

# **INSURANCE**

4FORALL doesn't offer group or personal accident insurance policy to its players/students or participants.

#### **MEDICAL CONSENT**

4FORALL will not permit any player to participate in any of the programs offered without a medical consent form completed by their parent(s)/guardian(s). By signing up to the programme you give your permission to allow yourself/your child to be given medical treatment either by way of first aid by a suitably qualified person or by a doctor. You also consent to yourself/your child being taken to a doctor or hospital in case of emergency.

4FORALL reserves the right to refuse an applicant based on the information provided in the medical consent form. If there is any change to the medical information you provided on your application form you must inform us immediately.

The parent and player hereby acknowledge, without prejudice to other clauses, that football is by definition a contact sport. 4FORALL shall not indemnify any player for any injury suffered whether it be in a training, coaching or match situation. The parent/guardian also acknowledges by confirmation of name given above that they will not seek monetary compensation from 4FORALLor any member of staff for any injury incurred during any football activity.

Note – Medical Certificate to be provided by any registered doctor.

# DAMAGES/INJURIES/LOSS OF POSSESSIONS

4FORALL is staffed by certified Coaches who will implement the highest safety measures. 4FORALL will not be held responsible for damages, injuries or loss of possessions. We strongly recommend that all valuables be left at home.

Under any condition, 4FORALL shall not be liable for any claim compensation/ reimbursement in any form for any and all medical expenses, both in practices and games and while travelling to and from training camp or match venues. All the participants/players have the right and responsibility to inspect the equipment and facilities prior to their participation.

#### **CONDUCT**

Participants must follow the instructions of the coaching staff in charge. Misbehaviour or bullying may result in the participant/student being expelled from the 4FORALL. In the interest of safety, participants (minors) are not permitted to leave 4FORALL premises/training venue/academy during the coaching session times without the written consent of a parent/guardian. If a minor player is expelled, their parent/guardian will be contacted immediately and appropriate arrangements for the collection of the player will be made should the participant not have parental consent to travel to and from the venue.

#### **GENERAL INFORMATION**

Either Head Coach or coach in charge will manage all coaching activities at the venue.

No outside interference will be allowed when sessions are in progress.

# PHOTOGRAPHIC OR VIDEO PERMISSION

All participants/students enrolled for 4FORALL program may be used in photographic or video material for promotional purposes by the 4FORALL without any compensation.

#### **WEATHER**

4FORALL shall not be accountable should the academy/training camp or any activity be suspended or cancelled due to adverse weather.

# THE TRAINING

We treat as a priority the safety and well-being of all children attending 4FORALL ACADEMY. We reserve the right to remove for a session/season any person who is found to be engaged in offensive activity, indiscipline, the bullying of others, disruptive behaviour or for any other reason where we consider a person's behaviour is detrimental to the interests or safety of the persons attending a class. If you are removed from a session/season for any of these reasons, you will not be refunded any fees already paid by you in connection with that session/season.

#### **CANCELLATION AND REFUNDS POLICY**

We reserve the right to cancel or reschedule a session/program at any time. In circumstances where such cancellation or rescheduling takes place less than 48 hours before the scheduled date we will contact you by a SMS or WhatsApp message.

4FORALL doesn't refund any fees, once your payment is made and enrolment is confirmed by us either by a message or call or mail.

# **INDEMNIFICATION**

You agree to indemnify, protect and hold harmless to 4FORALL ACADEMY, our subsidiaries, affiliates, partners, officers, directors, agents, Coaches and employees, harmless from any claim or demand, including reasonable attorneys' fees, made by any third-party due to or arising out of your breach of these Terms of Use or the documents they incorporate by reference or your infringement of any law or the rights of a third-party.
